The exhibitor agrees to make no claim, for any reason whatsoever, against ISCA, the Westin, or any other contractors for loss, theft, damage, or destruction of goods, or for any injury to self or employees. Nor will claim be made for any damage of any nature or character, including damage by reason of failure to provide space for the exhibit, or for removal of the exhibit or for failure to hold the conference as scheduled. No one under 18 will be allowed in the exhibit hall or any conference space.

### **Unoccupied Space**

Should any rented exhibitor space remain unoccupied on the opening day or should any space be forfeited due to failure to make payment, ISCA reserves the right to rent that space to other exhibitor.

### **Acceptability of Exhibits**

ISCA reserves the right to refuse to sell exhibit space to any company it deems objectionable or at cross purposes tot he association's mission. Exhibitors shall not place any promotional material on tables in common areas or the like outside their assigned exhibit space. Animals and machinery are not allowed without prior approval from management.

### Fire, Safety, & Health

The exhibitor agrees to accept full responsibility for compliance with local, city, and state fire, safety, and health ordinances.

### **Damages to Property**

Exhibitors are liable for any damage caused to the floors, walls, columns, tables, or any other exhibitor's property.

#### Cancellations and Deadlines

Any cancellation request must be made via email to the executive director (executivedirector@ilschoolcounselor.org) by October 18th, 2024 to receive a refund. In the event that the ISCA Conference is cancelled due to a "force majeure", a refund will be distributed to registrants. The conference app and website information cutoff date to add or edit information is October 18th, 2024. No changes will be permitted after this date. If artwork is not provided to ISCA by the due date requested, the organization will forfeit that sponsorship and no refunds will be given.

### **Guidelines for Display**

A standard exhibit will include a 6ft table with table cloth and two chairs. The height of the back of your exhibit may not exceed 8ft.

- Exhibitors are expected to have their tables fully set-up by 8am on Thursday, November 14th.
- Exhibitors are expected to stay fully setup until 2pm on Friday, November 15th.
- Exhibitors need to have all of their materials removed from the conference hall by 4pm on Friday, November 15th.
- You are not permitted to conduct business outside of your assigned space.
- · Payment is due at the time of registration.
- Exhibitors should keep assigned space neat and clean at all times.
- Exhibitors may not assign, sublet, or share any part of the exhibitor space.
- Exhibitors are solely responsible for monitoring their own property/materials.
- It is recommended that exhibitors include a take-away, give-away, or raffled gift to increase engagement. <u>Click here</u> to see tips for exhibitors.
- All raffles and gift must be awarded by the refreshment session on Friday.
